The schools shall abide by the rules and regulations laid down by the Education Department/NBSE. The schools shall set up proper Science and Mathematics laboratories and library for the students.

Permission to open Class IX & X shall be withdrawn at any time if the schools do not adhere to the rules, regulations of the Board issued from time to time and conditions given above.


