Dated Kohima, the 5th March 2022

No.NBE-4/Ad-VOC(10)/2021-22 :: In pursuant of the Government notification No. DSE/ESTT/NEP-2020/1-186/2020(Pt-I) dated Kohima, the 1st March 2022 and as per the recommendations of **National Education Policy (NEP) 2020** to provide exposure beyond the classrooms to give a better picture of the interconnectivity within a community through vocational education and thereby enhancing a deeper understanding of dignity of labour through hands on activities, it is hereby notified for information of all heads of registered schools under Nagaland Board of School Education and Private Elementary Schools that:

1. Pre-vocational education (10 bagless days) shall be introduced in all elementary schools (Class VI-VIII) in both Government and Private schools in the State **w.e.f academic session 2022**.
As envisaged in **4.26 of NEP 2020**, bagless days are to be encouraged throughout the year for various types of enrichment activities involving arts, quizzes, sports and vocational crafts.
2. Schools shall organize exposure visit of students to nearby workplaces to understand the interconnectedness between observations based learning and the workplace.
Children should be given periodic exposure to activities outside school through visits to places/monuments of historical, cultural and tourist importance meeting local artists and craftsmen and visit higher educational institutions in their area.
3. A practice based curriculum, shall be developed by SCERT in consultation with NCERT/PSSCIVE in different vocations for use in schools.
4. Meanwhile, a module has been developed by 'Lend a Hand India' catering to the local requirements for use in schools **w.e.f academic session 2022**.
5. Heads of schools shall identify teachers in respective schools for orientation training through SCERT/Samagra Shiksha/Vocational Training Providers and for taking up pre-vocational education.

The modules to be followed in the implementation of 10 bagless days have been uploaded in the Boards portal <https://www.nbsenl.edu.in> for reference and compliance.


