**Subject : Reminder for Implementation of APAAR ID as primary student identifier for schools registered under NBSE.**

Sir/Madam,

In pursuant of Government letter no DSE/AADHAAR/13-88/2013/595 dated 22<sup>nd</sup> January 2025 and as a reminder to letter NO. NBE-16/C0-Apaar/2024-2025:402 dated 20<sup>th</sup> Feb'2025, I am to inform all the Schools registered under NBSE particularly the private schools to continue the implementation of APAAR ID (Automated Permanent Academic Account Registry) as primary student identifier for every student on a '**Mission Mode**' till the saturation of all students in Classes IX to XII. The status of APAAR ID generation for the state of Nagaland is not satisfactory which indicate that schools are not taking it seriously.


The Heads of Institutions are therefore requested to educate parents and students as mentioned in the earlier circulars and ensure the saturated enrolment of students under their schools on top priority. Students are going to face problems in entrance test and admission support if they do not have the APAAR ID.

All Heads are to note this seriously and ensure the generation/creation of APAAR ID of their students at the earliest.

Subject : **Follow up for Implementation of APAAR ID as primary student identifier for schools registered under NBSE.**

Sir/Madam,

In pursuant of Government letter no DSE/AADHAAR/13-88/2013/595 dated 22<sup>nd</sup> January 2025 and as follow up to our letter NO. NBE-16/C0-Apaar/2024-2025:192 dated 28<sup>th</sup> Jan.'2025, I am to inform all the Schools registered under NBSE to continue the implementation of APAAR ID (Automated Permanent Academic Account Registry) as primary student identifier for every student on a '**Mission Mode**' till the saturation of all students in Classes IX to XII.

The Heads of Institutions are requested to educate parents and students not only on the benefits of APAAR ID registration but also the problems they will face without APAAR ID in the immediate future such as -

- i) Entrance Test and Admission Support : APAAR ID now serves as primary identifier for examinations like JEE, NEET and CUET simplifying the process of students and institutions and may soon become mandatory in the future.
- ii) Unified tracking : Transfer or joining new institutions will require APAAR ID as it facilitates comprehensive monitoring of students aiding in the reduction of dropout rates and improvement of learning outcomes.

**Subject : Implementation of APAAR ID as primary student identifier for schools registered under NBSE.**

Sir/Madam,

In pursuant of Government letter no DSE/AADHAAR/13-88/2013/595 dated 22<sup>nd</sup> January 2025, this is to inform all the schools registered under NBSE that the implementation of APAAR ID (**Automated Permanent Academic Account Registry**) as primary student identifier for every student is being emphasised on a 'Mission Mode' throughout the country by the Ministry of Education (MoE) in alignment with the NEP 2020 and vision for a 'Digital India'.

**APAAR ID:**

APAAR ID is a unique 12-digit identifier designed to consolidate students' academic and extra curricular records in a single secure digital platform. Integrated with the Digilocker ecosystem, it allows students to store and access their achievements, examination results, learning outcomes, and participation in activities such as Olympiads, sports and skill training. This system also supports the 'One Nation, One Student ID' initiative, ensuring continuity and accessibility throughout a student's educational journey.

The APAAR ID system adheres to the highest standards of security and privacy and ensures data confidentiality of the students.

**Objectives:**

- ✓ To provide a unified record of students' academic and non-academic achievements.
- ✓ To support seamless transitions during inter-school transfers or changes in states/districts.
- ✓ To enhance transparency and efficiency in educational administration.

**Advantages:**

- ✓ **Unified tracking:** Facilitates comprehensive monitoring of students educational journeys, aiding in the reduction of dropout rates and improvement of learning outcomes.
- ✓ **Digital Integration:** Directly links with Digilocker for storing academic records and extracurricular achievements.





- ✓ **Data-Driven Insights:** Consolidates academic, attendance, and performance data for real-time analytics and predictive interventions.
- ✓ **Ease of Transitions:** Simplifies the transfer of academic records across schools, districts, or states.
- ✓ **Enhancing Education systems:** APAAR ID integration with Vidya Samiksha Kendra enables detailed analysis of educational outcomes.
- ✓ **Entrance Test and Admission Support:** Serves as the primary identifier for examinations like JEE, NEET, and CUET, simplifying processes for students and institutions.

#### **APAAR ID Implementation steps for Schools:**

- ✓ *To Sensitise Parents:* Explain the importance and use of APAAR ID to parents and students by conducting Parent-Teacher meet.
- ✓ *Consent form:* Schools must distribute physical consent forms to parents, who need to sign and submit these forms to authorise the use of Aadhaar details for generating APAAR IDs.
- ✓ *Student Data Verification:* School authorities should verify student details (e.g., name, date of birth, Aadhar number) on the UDISE+ portal for accuracy.
- ✓ *APAAR ID Generation:* Using the UDISE+ portal, schools will generate APAAR IDs, which will be securely linked to students' Digilocker accounts. Confirmation SMS will be sent to parents.
- ✓ *Distribution and Integration:* Schools will provide APAAR IDs to students and parents, ensuring they are included on school ID cards and integrated in the schools record entries.
- ✓ *Addressing Errors:* If any discrepancies arise, schools should guide parents to Common Service Centres (CSCs) for corrections.

In this regard, schools are requested to ensure APAAR ID creation for all students to support students seamless educational journey in academic record management. Priority should be given to Classes IX to XII students creation of APAAR ID. As informed earlier, schools are to continue observing **“Mega APAAR Diwas” on the 9<sup>th</sup> & 10<sup>th</sup> of every month to reach saturation of APAAR IDs on a priority basis.**

The Heads of Institutions are requested to educate the parents and students about the benefits of APAAR ID registration, as mentioned above and also the likely difficulties students may face in their future academic pursuits due to non-registration.


