# 1. HSLC & HSSLC Examinations 2021 Application Forms:

If the designated centre /school have received the application forms from all the centre schools, they can submit the filled in forms to the Board even before 11<sup>th</sup> December 2020. However, centre schools are reminded that the forms from all the schools under them should be collected.

#### 2. Late submission of Forms:

The last date for receipt of HSLC & HSSLC Examinations 2021 application forms with late fine of ₹500/- per candidate is 18<sup>th</sup> December 2020. Late candidates can submit their forms directly to the Board with the application duly signed by the concerned school/centre school.

#### 3. Issue of Duplicate documents:

Students can apply for duplicate documents online at nbsedup@gmail.com. The prescribed fee along with a postal charge of ₹50/- shall be paid to SBI account NBSE FEE RECEIPTS, A/C No. 39353961985, IFSC – SBIN0000214. The scanned copies of the payment receipt and a supporting document like Admit Card, Marksheet etc. should be sent.

It may be noted here that application sent to other emails of the Board will not be accepted. It should be sent to the address given above.

Proper postal address of the student should be indicated clearly in the application. The Board shall send scanned copy of the duplicate document through email and the hard copy will be sent by post.
