NO.NBE-30/Ad-VIII/2022-23:: In the interest of the schools and students community, the following is hereby notified for compliance by all schools:

- 1. The Class VIII and Class IX Final Examination 2022 (Phase-II) shall be conducted in offline mode.
- 2. The Phase-II of both Class VIII and Class IX examinations is fixed from 29th November 2022 to 6th December 2022.
- 3. The Board shall provide Question papers for Class IX Final Examination of all the subjects to the schools.
- 4. The Board shall provide Class VIII Question paper to all Government schools, whereas the private schools shall prepare their own Question paper based on this assessment pattern and conduct the examination with the same routine for Class VIII Final Examination 2022.
- 5. Graph papers shall be needed in Mathematics Classes VIII and IX and Music Manuscript in Class IX. Therefore schools, should keep it ready.
- 6. The Question papers of Class-VIII and Class IX subjects shall be as per the division of topics and marks uploaded in the Board's portal. But for Class IX Social Sciences, Science and Mathematics it will be as per rationalized syllabus vide Notification No. 80/2022 dated 12th August 2022.
- 7. Only 50% of the total marks will be set/conducted for Phase-II examination in all the subjects.
- 8. The duration of Phase-II examination will be 90 minutes for core subjects and 60 minutes for the vocational/ sixth subjects.
- 9. The minimum qualifying marks in different subjects for Phase I & II Examination is given below:

Full Marks	Qualifying Marks
40	16
35	14
25	10

- 10. Students must secure minimum qualifying marks in each subject for both Phase-I and Phase II Examination.
- 11. Provision for retest and remedial measures for Class VIII as per RTE Act shall be followed by all the schools.
- 12. Password protected PDF file Question Papers for Phase-II examination will be uploaded in NBSE portal **www.nbsenl.edu.in**, one day ahead of the examination at 8:00 am in the morning for every subject as per the routine.
- 13. The password file will be uploaded on 24th November 2022. The schools are to login to the portal and download the password file. The code for opening the password file will be sent via SMS to the registered mobile number of the schools given in the portal. This is done to do away with the previous method of obtaining password from the Board's Officials/office.
- 14. Only the Head of Institution shall login to the portal and download the password file.
- **N.B:** Schools should update the registered mobile number in the portal to get the SMS at the earliest.
 - A test password file shall be uploaded in the portal on 18th November 2022 for the schools to test run.

- 15. The Head of Institution shall maintain confidentiality of the PDF of the Question Papers. He/She shall ensure that printing of the question papers are done within the school office/premises only taking all confidential measures. The Head shall be held responsible for any lapse/leakage of the question paper as per rules.
- 16. Schools shall carry out the internal assessment in all the subjects and record the marks for inclusion in the final results preparation.
- 17. The consolidated marks of Phase-I & II with the internal assessment marks shall be submitted together to the Board's Office after the conduct of Phase II examination.
- 18. The last date for submission of the results will be on 17th December 2022.
