Dated Kohima, the 6th December 2022

NO.NBE-1/Ex-9/2022-23 :: It is hereby notified once again for information of all the Heads of Schools to note the following points:

1. The Centre schools of Government schools (which was notified vide Notification no. 92/2022 dated 7th September 2022) shall constitute an Evaluation Committee comprising of subject teachers from centre school and the feeding schools. These teachers shall jointly evaluate the answer scripts of their students.
2. The Centre Superintendent shall coordinate closely with their Heads of the feeding schools while preparing the result of Class VIII Examination. The result sheet of the feeding schools shall be handed over to the heads of the feeding schools to upload the result to the portal.
3. While entering the marks in the PCR, the consolidated marks of Class VIII and IX Phase-I & II Final Examination 2022 should be entered in the **Fourth Quarterly Assessment** and the consolidated marks along with internal assessment marks should be uploaded in the NBSE portal by all registered schools of the Board.
4. Utmost care should be taken to see that correct results and particulars are submitted to the Board. Schools should enter the results in the offline software and save the file. Schools should first open the file, get a print out and check if the entered results are correct. Only after ensuring that the results are complete and correct, it should be uploaded for approval.
5. **Documents to be submitted through Speed Post within 20th January 2023.**
 - (i) Specimen signature of the Principal/Headmaster/Headmistress
 - (ii) Valued answer scripts of Class VIII & IX of both Phase-I and Phase-II Final Examination 2022 shall be submitted by all schools (Govt. & Private) in the following range:

Class-VIII

3 (three) scripts within 0-15 marks, 3 (three) scripts within 16-31marks,
3 (three) scripts within 32-40 marks.

Class IX


