NO.NBE-21/Ex-Recog/2022-23 :: It is hereby notified for information of all concerned that action is being taken against the following schools for reasons given against their names:

**A.** Permission to run Class XI & XII is given for 1(one) year only i.e. 2023 academic session, to the following school for reason shown against its name.  
1. **C.D. King Higher Secondary School, Jotsoma** - Very low enrolment  
(Class A to XII – 117)

**B.** Permission to run Class IX & X is given for 1(one) year only i.e. 2023 academic session, to the following 2(two) schools for reasons shown against their name.  
1. **Genesis School, Kohima** - Low enrolment and poor infrastructure.  
(Class A to X – 95)  
2. **Children Christian School, Kohima** - Very low enrolment (Class A to X – 72)

**C.** During inspection, it was detected that the following 2(two) schools have given inflated enrolment as on 1<sup>st</sup> April 2022:

1. **Little Angel Higher Secondary School, Thilixu Village.**

The school was given permission to start Class XI in 2022. The school had given inflated enrolment of 519 (Class A – XI) where as only 282 were enrolled.

**The school shall be barred from admitting students in Class XI for 1 (one) academic year in 2023 session. However, the Class XII students will be allowed to continue in 2023.**


2. **Cedar School, Chümoukedima.**

The school was given permission to start Class IX in 2020. The school had given inflated enrolment of 260 (Class A – X) whereas only 174 were enrolled.

**The school shall be barred from admitting students in Class IX for 1 (one) academic year in 2023 session. However, the Class X students will be allowed to continue in 2023.**

In case of repeated offence of giving false information to the Board, permission for upgradation/recognition shall be withdrawn without further notice.

Further, any school giving false information to the Board shall be dealt with accordingly.


