NO.NBE-14/Ex-Misc(12)/2023-24 :: It is hereby notified for information of all Heads of Institutions of NBSE that the sample front page (cover) of the Answer Booklet for HSLC and HSSLC Examinations has been uploaded in the Board's Portal **nbsenl.edu.in.**

The Heads are directed to download the sample and instruct the students/candidates thoroughly on how to fill in the particulars **i.e. the subject**, **examination date**, **roll number in words and how to darken/shade the numbers corresponding to the roll number in the OMR format** correctly, as many students commit mistakes in the OMR sheet.

It is observed that some schools are **not** giving proper training/instructions to their students to fill-up the OMR. Students/candidates must be cautioned that writing the wrong roll number or shading/darkening the wrong number in the OMR will be auto rejected by the machine.

Further, it is important for the teachers to know the process of filling-up the front page (cover) of the answer booklet as checking entries in it is a part of invigilation duty. Therefore, Heads of institutions are requested to inform the teachers also to be thorough and be acquainted properly on how to fill-up the entries on the front cover of the answer-booklet.
