No.NBE-8/Ad-Misc(10)/2025-26:: This is to inform all the Heads of Registered Institutions of NBSE, that the following **Precautionary Measures for Schools are issued for necessary action amidst Prevailing Hot Weather Conditions**. In light of the ongoing heat wave particularly in the plain areas of the state, all the registered schools are hereby directed to take appropriate steps to safeguard the health and well-being of students and staff. The following measures are to be implemented:

1. **Ensure Proper Ventilation and Cooling**
All classrooms must be equipped with functional fans. Schools are advised to arrange backup power supply or alternative cooling arrangements (such as coolers or battery-operated fans) in case of power outages.
2. **Provision of Adequate Drinking Water**
Sufficient clean and cool drinking water must be made available at multiple accessible points within the school premises throughout the day.
3. **Modification of Morning Assemblies**
Morning assemblies must not be conducted outdoors. Schools should conduct them indoors or via classroom announcements to avoid exposing students to direct heat.
4. **Monitoring During Recess and Breaks**
Staff should actively monitor children during breaks and recess for signs of heat stress or exhaustion. Immediate medical attention must be provided if any student is found unwell due to heat.
5. **Flexible Uniform Guidelines (Optional)**
Schools may consider relaxing uniform norms temporarily, allowing lighter and more breathable clothing to help students stay cool.
6. **Heat Awareness and Hydration Education**
Teachers should sensitize students about the importance of staying hydrated, avoiding physical exertion in the sun and recognizing early symptoms of heat-related issues.

These measures are to be followed until further notice. The cooperation of all institutions is sought in ensuring the safety and comfort of students during this period of time.
